Are You Biased against Women Leaders?

Women have been leaders throughout history, and today the tradition of volunteer female leadership continues to flourish. Yet in terms of paid leadership, women's elevation to top positions is relatively rare. Why do men still vastly outnumber women in these positions?

If asked, most of us would say that discrimination against women in the workplace is wrong and unacceptable. Unfortunately, research shows that treating women and men equally in hiring decisions, job evaluations, and leadership positions is more of an ideal than reality. We all have implicit bias. Psychology research shows that most Americans associate positively with white people and negatively with African Americans, an association that has pervasive effects on our society. Studies of racial bias were some of the first to use implicit measures. These measures allow investigation of attitudes or associations that people may consciously deny or reject, or even be unconsciously aware that they have.

Bias matters. Perhaps unsurprisingly, given the pervasive gender association documented by researchers, academic scientists who evaluated identical resumes belonging either to "John" or "Jennifer" perceived Jennifer as less competent.

We can reduce bias! Fortunately, studies suggest that it may be possible to reduce bias in our minds and in our workplaces. One study found that systematic consideration of personal judgments could help combat bias in the evaluation of women in leadership positions, while another study of university professors found that a program of anti-bias education improved the environment in their departments.

AAUW's newest research report, *Barriers and Bias: The State* of *Women in Leadership*, explores this question by drawing from scholarly research and by paying special attention to stereotypes and biases. Source: AAUW *Leadership*

LAF Individual Giving

LEGAL ADVOCACY FUND and Sexual Harassment

How is the money we send to the Legal Advocacy Fund used? Educating girls and women students about their rights is one important part of LAF's mission.

Last month Doris Nistler discussed *Title IX* of the *Education Amendments of 1972*. This comprehensive federal law prohibits sex discrimination in education. It covers women and men, girls and boys, and staff and students in any educational institution or program that receives federal funds. Local school districts, colleges and universities, for-profit schools, career and technical education agencies, libraries, and museums are all covered under *Title IX*.

Women and girls need to know that sexual harassment and sexual violence disproportionately affect college women and impede their ability to participate fully in campus life. Both sexual harassment and sexual violence are forms of sex discrimination covered under *Title IX*. *Title IX* protects students from sexual harassment and violence that occur in the course of a school's education programs and activities. Once a school knows of, or reasonably should have known about sexual harassment or sexual assault on campus, *Title IX* requires the school to promptly investigate the complaint and take steps to protect its students.

The Legal Advocacy Fund promotes programs to aid students who have faced sexual harassment or sexual violence. Students can file an internal complaint with the school and the school can take steps to prevent further harassment. Those steps could include changing a class schedule, prohibiting the perpetrator from contacting the student, or even expelling the perpetrator. If a student believes the school has failed to investigate complaints or protect its students, a complaint can be filed with the U.S. Department of Education's Office for Civil Rights (OCR), the federal government agency charged with enforcing *Title IX*.
