

At our Ballwin-Chesterfield branch, we are working at several high schools with young women, as they endeavor to go into STEM. We also give scholarships to non-traditional women students in college who are going into STEM fields.

A new AAUW endeavor is a focus on impacting change; that is, how to take what is learned and translate that into action? This focus is what's behind AAUW's *Charting the Course* major gift campaign, whose goal is to raise one million dollars in unrestricted funds to use so AAUW can respond quickly to new challenges facing women. AAUW can create research, programs, and advocacy initiatives to meet new challenges when needed, instead of raising the funds to use before AAUW can act. PUBLIC POLICY

The *Breaking the Chains of Human Trafficking Symposium*, January 12, was very successful with nearly 100 people in attendance. St. Charles County Assistant Prosecuting Attorney Jillian Anderson was the keynote speaker and told the group what's happening in St. Charles County. Anderson shared two cases in which traffickers were prosecuted and encouraged community groups to work together.

The *Vulnerability and Recruitment, Exploitation*, and *Victims* break-out sessions were thought-provoking and challenged advocates to truly see victims that are in plain view. The more dysfunctional home life is for a young person, the greater vulnerability a victim may display. Recruitment is done through cyber sites and gathering places where young people go, such as malls and school sports events. The recruiter may be similar in age and can be male or female. Recruiters/traffickers tend to create a bond and loyalty that controls all aspects of the victim's life. Force, fraud, and coercion are used by traffickers to exploit victims into lives of servitude and abuse. Victims experience a lifetime of scars and ramifications that include PTSD, anxiety and mood disorders, substance abuse, depression, and multiple defense mechanisms.

Christine McDonald, author of *Cry Purple*, spoke from her heart about her experiences from victim to author. Only after hitting rock bottom did Christine find the will to seek help to change her ways after 20 years of unhappiness, homelessness, prostitution, drug addiction, horrendous violence, and convictions. Detective Dan Maxiner of the St. Charles County Sheriff's Office stated it is difficult to identify victims of labor and domestic trafficking, but if something looks suspicious, report it to the Human Trafficking Hotline: 888-3737-888. Hopefully, new legislation will help control trafficking everywhere.

EDUCATIONAL OPPORTUNITIES FUND

LAF in Action

Good news! We have a million dollar win in the case supported by the AAUW Legal Advocacy Fund, *Moshak v. University of Tennessee*, which LAF took on in 2014. In 2012, Jenner Moshak and two former coaches of the national title-winning Lady Volunteers basketball team filed suit against the university, alleging sex discrimination and unlawful retaliation under *Title VII of the Civil Rights Act of 1964*, *Title IX of the Educational Amendments of 1972*, and the Equal Pay Act of 1963. The plaintiffs claim they were unlawfully discriminated against and eventually forced out of their positions during a university-led merger of the men's and women's athletic departments. They further claim that during this merger, 86 percent of the positions eliminated were held by women or were associated with the women's athletic department. Trial was scheduled for June 2015 in the U.S. District Court for Eastern Tennessee. On Jan. 6, 2016, AAUW received news that the University of Tennessee will pay the plaintiffs more than a million dollars, with the added bonus that it does NOT contain a confidentiality clause, so the plaintiffs may continue as speakers and advocates.

Did you notice that these laws were passed more than 40 years ago? Gender discrimination still exists in highly respected not-for-profit institutions. Even at schools where female athletes have achieved great success, there exists a deep level of institutionalized gender discrimination when it comes to valuing women's sports and women athletes.

Your contributions make progress happen! The AAUW Legal Advocacy Fund has been crucial to the success of many gender discrimination cases during its 33-year history. In March, we will seek your individual contributions to LAF. Remember, after the hard work of getting anti-discrimination legislation passed, continued efforts are needed to see that these laws are upheld in the courts. Your support is needed and appreciated.
