- Utilize resources from AAUW on diversity and inclusion.

# Mental Health - the Importance of Strengthening Medicaid of Missouri's Mental Health System

### Jacqueline Lukitsch, Director of Advocacy National Alliance on Mental Illness (NAMI)

Under the leadership of Director Lukitsch, NAMI St. Louis expanded programs to reduce incarcerations and injuries to people with severe mental illness throughout Missouri. She was instrumental in securing funding to implement Assertive Community Treatment Teams (ACT) statewide.

Likitsch serves as co-chair of the Missouri Federation of Advocates for Mental Health and Substance Abuse Services and as a member of the steering committee for the Missouri Medicaid Coalition.

Healthcare and advocacy are AAUW priorities. Funding for mental health is a serious concern in our society.

### **PUBLIC POLICY**

The past year, 2014, has been quite a year for AAUW from empowering women at the ballot box to continuing groundbreaking efforts to close the pay gap.

AAUW's Lisa Maatz stood with Lily Ledbetter and the president as he signed executive orders to ban federal contractors from retaliating against workers who discuss their salaries. Thanks to these efforts, the U.S. Department of Labor will now collect wage data to help identify patterns of discrimination and support compliance.

AAUW promises to keep the momentum to empower women and girls in 2015. Some key challenges include these:

- the 22 percent gender pay gap that has barely budged in decades
- schools that disadvantage our daughters and granddaughters in science and math
- the lack of women elected to public office
- the barriers that women and girls face in our workplaces, schools, and legislatures.

All are unacceptable.

Looking forward, AAUW is excited about completing research which addresses biases and stereotypes that have held women back in engineering and computing fields. This spring, AAUW will launch its new report to delineate the concrete actions that families, schools, workplaces, and policy makers can take in the years to come.

College women have been helped to advocate for themselves and learn how to negotiate their salaries through \$tart \$mart workshops. In 2015, AAUW seeks to empower professional women to negotiate better salaries and benefits with the new tool Work \$mart.

AAUW remains a leader in leveling the playing field for women and girls.

### **EDUCATIONAL OPPORTUNITIES FUND**

### LEGAL ADVOCACY NEWS

Medicaid Issues in Missouri

Missouri has continued to refuse to expand its Medicaid system under the 2010 federal health care law. Our state legislature has decided not to expand its Medicaid rolls to residents who make as much as 133 percent of the federal poverty level, or about \$31,000 a year for a family of four. As a result of this decision, over 14,000 Missourians do not make enough money to qualify for subsidies in the federal health care exchange, but make too much to qualify for Medicaid.

This coverage gap is expected to affect more people each year. Hospitals are feeling the fiscal pinch of reduced reimbursement, which may affect care for uninsured patients. Each year, our state rejects roughly \$2 billion in federal subsidies that will continue until 2020. After 2020, the federal share of the costs of expanded coverage is set to drop to 90 cents on each dollar, leaving the other dime to the state. The concern of the Republican opponents is that the issue is not just about one dime, but rather about millions of dollars' worth of dimes and the fear that the federal government might reduce its share.

Is it fair to reduce health (including prevention) services for thousands of Missourians and to lose \$2 billion each year? Or, is it fair for our legislature to hold tight on expenditures that will increase after 2020?

LAF will keep you informed about future state legislative action on this important matter.

### MARY MCLEOD BETHUNE (1875-1955)

#### Invest in the human soul. Who knows, it might be a diamond in the rough.

Mary McLeod Bethune's words guided her as an educator and advisor. Born after emancipation to parents who had been slaves, Bethune's inspiring story is one devoted to learning and service. Bethune burned to bring education to other African Americans. She founded an elementary school focused on educating young girls and the Bethune-Cookman College. Bethune served in the Franklin D. Roosevelt administration and founded the National Council of Negro Women in 1935. Mary's words to her students inspire young people still today:

I leave you love. I leave you hope. I leave you the challenge of developing confidence in one another. I leave you respect for the use of power. I leave you faith. I leave you racial dignity.
