A Divided America: Growing Economic Divides

Ana Kent, Ph.D. Policy Analyst Center for Household Financial Stability The Federal Reserve Bank of St. Louis

Dr. Kent conducts primary and secondary research and data analysis on household balance sheet issues. Her primarv research interests at the Fed include economic disparities and opportunity, wealth outcomes, class and racial biases and the role of psychological factors in making financial decisions.



Dr. Kent will highlight income and wealth inequality in the United States and will disentangle existing racial, educational, and generational wealth gaps, including changes over time. Research by the Center has found that these three demographics are strong predictors of who is building wealth in this economy and who is not. In general, younger, less-educated, and Black or Hispanic families from are. а wealthbuilding perspective, "struggling," while older, bettereducated, and white families are, generally "thriving."

Kent received her doctoral degree in experimental psychology from Saint Louis University, her master's of science from St. Louis University and bachelor's degree from Notre Dame.

Public Policy

Many have voted in the November 3 election, but you, your family, or friends, may not have yet done so. What can you still do? Remind everyone TO VOTE; their vote is their voice. Let all know they can vote at the board of elections or at the satellite offices. Reminder—there are two ways to vote by mail, either absentee or mail-in. If you are using an absentee ballot, and selected option 2 or 7, your ballot does not need a notary and can be dropped off or mailed. If you are using a mail-in ballot, or absentee ballot for any other reason, it must be notarized and be **sent by mail**. Find a notary at <u>https://notaryhub.movpc.org</u> of the nonpartisan Missouri Voter Protection Coalition. For questions or concerns, call I-866-OUR-VOTE. AAUW encourages members to advocate for its issues. AAUW MO opposes Amendment 3–VOTE NO on #3. The AAUW Action Network states that "we fight for a just and fair Supreme Court" by telling the Senate to prioritize the American people and wait to hold the Supreme Court hearing until AFTER the inauguration. You can do this by texting: saveourcourt to 21333.

We also are in the final days of Domestic Violence Awareness Month–another AAUW priority "freedom from violence and fear of violence..." Domestic violence was already an epidemic before COVID, but the health crisis has caused a spike in incidences of violence. One in four women and one in ten men have experienced contact sexual violence. A local crisis intervention hot line currently has seen a 44 percent increase in calls. If you or someone you know who might need help, have them call Safe Connections 24-Hour-Crisis Helpline, 314-531-2003, or the National Domestic Violence Hot line,1-800-799-7233.

Ballwin-Chesterfield has online presence in several areas: emails to members, a website, and a Facebook presence. To provide protection for members, the branch no longer provides "live" links to personal email addresses when publishing online, as these may be picked up by unwanted sources. The plain text email addresses may be copied and used for personal purposes. Links to commercial and public sources will remain "live" (i.e. <u>www.aauw.org</u>).

Security on the internet is provided in several ways. Individuals may purchase security from their computer store or a private source. Many providers, such as Apple and Microsoft, provide free security for their products. Always look for the padlock when making online purchases or commercial contacts, as this indicates the site is secure.

New Legal Advocacy Fund Cases

AAUW's Legal Advocacy Fund has accepted two new cases. They are as follows:

Beth Page, et al. v. Mark Green Administrator, U.S. Agency for International Development (USAID) This is a pay equity case between three foreign service officers and USAID, relating to salary history and a violation of the equal pay act.

Glasson v. Google This is a pregnancy discrimination case brought by a former Google employee who also claims she was retaliated against.

Renewed STEM Momentum

In the national newsletter, *Mission & Action*, AAUW recently made the following exciting announcement concerning AAUW's emphasis on STEM. "Thanks to a generous bequest from AAUW member and scientific pioneer Nancy Grace Roman, AAUW is pursuing several important STEM initiatives this fall. Roman, who died in 2018, served as NASA's first chief astronomer and is known as the mother of the Hubble Telescope."

Here are the planned STEM initiatives that are getting underway.

- Assessing how parents influence high-school girls' choices about whether to pursue science, with the goal of
 identifying barriers to STEM participation and solutions for overcoming them. The information gleaned will
 strengthen communications with parents and support of first-generation college students, particularly women of
 color, in choosing STEM.
- Researching where women especially women of color are not gaining in STEM fields. These findings will
 enable matching women STEM majors with the most promising jobs of the future in computer science,
 technology, engineering and the physical sciences.
- Building an inclusive, ever-growing group of AAUW Fellows and alumnae to serve as STEM role models and mentors for women.
- Bolstering AAUW's fellowships and grants in STEM careers.

Be sure to keep an eye out for future news on how these objectives are being met.
