### Missouri Amendment 3 Update By Public Policy Committee Member Marge Anderson

Missouri's Amendment 3, passed in November 2024, enshrined abortion rights in the state constitution, overturning the previous near-total abortion ban. However, abortion access in Missouri remains limited due to ongoing legal and legislative challenges.


In February 2025, Republican lawmakers filed joint resolutions in both the House and Senate in response to a Jackson Count Judge's ruling that temporarily blocked regulations requiring abortion clinics to be licensed in the state. Additionally, a recent court ruling temporarily blocked several state laws restricting abortion providers, including a 72-hour waiting period, deeming them unlawful under the new constitutional right to abortion. These rulings have allowed abortion services at Planned Parenthood clinics in Kansas City and St. Louis to resume.

As of the first week in March, a proposed constitutional amendment, SJR 33. reinstating Missouri's abortion law cleared the Senate committee reviewing the amendment. It is now on its way to the full Senate for debate.


While Amendment 3 has restored abortion rights in Missouri, access to abortion services remains limited and subject to ongoing legal, legislative, and political challenges.

### AAUW NATIONAL DUES INCREASE By Managing Director and Chief of Staff Shannon Wolfe Reprinted from March 10, 2025, AAUW Document

The AAUW Board approved a modest dues adjustment — \$2 per year over the next two years. New national dues: \$74 starting April 1, 2025, and \$76 starting April 1, 2026.

Member dues are an important funding source for AAUW. While costs for member support increase annually, dues have not kept pace. During the feedback process, we heard from more than 750 members. The Board's decision to increase dues by \$2 reflects an adjustment to the original proposal to lessen the burden of a dues increase on members while keeping pace with inflation.

Your national member dues help fund services such as:

- •Administrative Support: Assist with dues processing, Community Hub management, 990N filings, branding materials, and toolkits (e.g., DEI Toolkit, College/University Member Toolkit).
- •Website Support: Update and manage ~500 branch and state websites and provide ongoing Site Resources support.
- •Member Trainings: Hold regular virtual member gatherings and training programs.
- •Member Engagement: Organize member-led groups and committees like Archives Corps, Lobby Corps, and national committees.
- Speaker Engagement: Offer National speakers for branch meetings and state conventions.
- •Real-Time Support: Connect Team provides daily assistance and semi-weekly "Office Hours" for member leaders.

The bottom line: We heard you. The dues increase balances AAUW's financial sustainability with the member feedback we received. Thank you for being an engaged leader!



#### Online Security By Sue Shineman, AAUWMO President

There have been several AAUW MO members whose email, phone, and texting, have recently been hacked. This information is timely. A few simple guidelines:

If you do not recognize the sender do not open any links within the email or text.

If an email address looks strange with letters and numbers, do not respond to it.

Send the message to SPAM and then delete everything in your SPAM folder.

If you discover you have been hacked, please share it with your branch president, and other organizations that you belong to. Share on your social media that you have been hacked, so others do not respond to your 'fake' requests. ### Snippets From the <u>AAUW Fiscal Year 2024 Annual Report</u> By AAUW Fund Director Karen Francis

#### There are Forty-One Thousand AAUW Members.

Seventy-one percent are branch members.

Twenty-six percent are national members.

Two percent are student members.

One percent are college/university members.

#### Fourteen Percent of Our Membership Pays No Required Fees to National.

Three thousand are lifetime members who pay one time for lifetime membership. They do not pay any more national dues, but they may pay branch and state dues.

Six thousand are Honorary Lifetime members who have been 50-year members and often pay no additional branch or state dues.

#### These are the Branch Sizes.

Ten percent have more than 100 members. Ballwin-Chesterfield is in this group.

Twenty-seven percent have 50-99 members.

Fifty-three percent have 10-49 members.

Ten percent have 10 or fewer members.

#### Why We Ask for Donations to AAUW Fund.

Ninety-six percent of all funds are donor restricted.

Four percent, are without restrictions to help AAUW address emerging priorities, stay agile in supporting branches and states, and work for women and girls.
